

**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
Alpha English School, UJJAIN  
AND  
MAHARAJA COLLEGE, UJJAIN**

This Memorandum of Understanding (MoU) is made and entered into on this 6th day of April, 2024, by and between Alpha English School (AES), located at Indira Nagar, Ujjain , and Maharaja College, Ujjain (MCU), located at Dewas Road, Ujjain.

**1) PURPOSE**

This MoU aims to establish a collaborative partnership between MCU and AES to promote academic excellence, research initiatives, and faculty/student development programs in the field of education.

**2) SCOPE OF COLLABORATION**

Both institutions agree to collaborate in the following areas:

- a. Exchange of knowledge, research, and best practices in education.
- b. Joint seminars, conferences, and workshops for students and faculty members.
- c. Implementation of skill development and training programs.
- d. Facilitation of internships, teaching practice and experiential learning opportunities.
- e. Collaborative research projects and publication initiatives.
- f. Faculty exchange programs for knowledge enhancement.

**3) RESPONSIBILITIES OF ALPHA ENGLISH SCHOOL , UJJAIN**

**AES agrees to:**

- a. Provide necessary support for teacher training programs and school-based research.
- b. Offer its premises for workshops, conferences, and academic activities.
- c. Facilitate student internships and teaching practice opportunities.

**4) RESPONSIBILITIES OF MAHARAJA COLLEGE, UJJAIN**

**MCU agrees to:**

- a. Conduct research studies on educational methodologies applicable to school education.
- b. Organize faculty development programs, guest lectures, and academic events.
- c. Support students of SHSS in academic projects, competitions, and mentorship programs.

**5) IMPLEMENTATION AND REVIEW**

- a. A joint committee comprising representatives from both institutions shall oversee the implementation of this MoU.
- b. The MoU will be reviewed annually to assess progress and make necessary amendments.

**6) DURATION AND TERMINATION**

- a. This MoU shall remain in effect for a period of three (3) years from the date of signing.
- b. Either party may terminate this MoU by providing a written notice of at least 60 days.

**7) GENERAL TERMS**

- a. This MoU is a statement of intent and does not create any legally binding obligations.
- b. Any disputes arising out of this MoU shall be resolved through mutual discussion.


